1. Getting Started

1.1. Package Contents

The following items are included in your product box.



NOTE: The illustrations may differ slightly from the items shipped with your product.

1.2. Fastening the poster



As illustrated in figure, positioning 2 holes on the earth and drill the holes at the corresponding position. The diameter of the hole on the earth should be smaller than the diameter of the screw. Fit the two fastening screws, fastening the Poster to earth.

1. USB 1 (DC 5.0V/0.5A)

USB for the poster. This USB port can't not use for FW update.

2. USB 2 (DC 5.0V/0.5A)

USB for the poster. This USB port can't not use for FW update.

3. RJ45

Enable connection to cable and log on to Internet.



1. DP(DisplayPort) INPUT

Connect an external device to DP out jack.

2. HDMI1/2/3 Input

To connect with those equipments with HDMI or DVI interface. HDMI 3(ARC): Connect an ARC-enabled home theater receiver to this jack.

3. USB 2.0

Connect USB devices to this port for Android. **NOTE:** It must be used if you upgrade software.

4. TOUCH OUT1/2

Connect an external device to support touch control of the external device on the Poster. **NOTE:** Touch out 1 corresponds to the HDMI 1, Touch out 2 corresponds to the HDMI 2, HDMI3, DP or VGA.

5. PC IN

Enable connection to PC or other external devices with VGA/AUDIO ports.

6. S/PDIF digital audio output

Connect a digital sound system to this jack.

7. ດູ

Connect headphones to this jack. The Poster is the current audio output.

8. RS-232

For remote control, service and other uses.

9. RJ45 (LAN IN)

Enable connection to cable and log on to Internet.

10. AC OUT

Only use one power supply, ~100-240V 50Hz/60Hz, Current Max. : 0.65A.

11. AC IN

Plug the AC cord into this jack and into a power outlet.(~100-240V 50Hz/60Hz).

12. Power Switch

Push to (1) to connect the power, push to (O) to cut off. **NOTE:** Power switch can not be covered, and should keep the power switch can be conveniently operated.

2. Parts and Functions

2.1. Remote Control



Notes:

• For touch model, some functions could be performed through touch directly instead of remote control.

2.1.1. Installing remote control Batteries

To install remote control batteries:

- 1. Open the battery cover.
- 2. Insert two AAA batteries into the battery compartment. Make sure that the + and symbols on the batteries match the + and symbols in the battery compartment.
- 3. Replace the cover.

Battery precautions:

Improper use of batteries can result in a leakage of chemicals and/or explosion. Be sure to follow the instructions below.

- Place batteries with their terminals corresponding to the (+) and (–)indications.
- Different types of batteries have different characteristics. Do not mix batteries of different types.
- Do not mix old and new batteries. Mixing old and new batteries can shorten the life of new batteries and/or cause old batteries to leak chemicals.
- Remove batteries as soon as they are non-operable. Chemicals that leak from batteries can cause a rash. If chemical leakage is found, wipe with a cloth.
- Dispose of batteries in a proper manner.
- If the remote control is not used for an extended period of time, remove the batteries.
- The batteries shall not be exposed to excessive heat such as sunshine, fire or the like.

2.1.2. Aiming the remote control

Use the remote control by pointing it towards the remote sensor on the front of your display. Objects between the remote control and the remote sensor may prevent proper operation.

Cautions regarding use of remote control

- Do not expose the remote control to shock. In addition, do not expose the remote control to liquids, and do not place in an area with high humidity.
- Do not install or place the remote control under direct sunlight. The heat may cause deformation of the unit.
- The remote control may not work properly if the remote sensor window of the main unit is under direct sunlight or strong lighting. In such a case, change the angle of the lighting or the display set, or operate the remote control closer to the remote sensor window.





3. Connections

- Turn off the display and connected device.
- Check the plug type at the ends of cables.
- Make sure the fastened connection.



NOTE: Before using headphones, adjust the device volume so as to avoid excessive levels, as hearing damage may result.

Connect TOUCH OUT with USB cable to PC USB port.

Connect PC with VGA cable, HDMI cable or DP cable. Please choose the proper method of connection based on your device. (Only for PC, HDMI, DP signal)

Touch out 1 corresponds to the HDMI 1, Touch out 2 corresponds to the HDMI 2, HDMI3, DP or VGA.

NOTE: After installation of the driver, it can control the external computer by native touch control.

4. Basic Operations

4.1. Turn on the display

Plug the power cord and turn on the AC **Power Switch**.

4.2. First initiation

The following installation menu will pop up for first-time power on.
